It has long been demonstrated that the Rockefeller interests have created, built up and developed the most far-reaching industrial empire ever conceived in the mind of man. Standard Oil, ordered dissolved by the courts in 1911 for monopolistic crimes, but today the giant Exxon Corporation. is of course the foundation industry upon which all of the other industries have been built. The story of Old John D., as ruthless an industrial pirate as ever came down the pike, is well known.

The keystone of this mammoth empire is the Chase National Bank with 27 branches in New York City and 21 in foreign countries (now renamed the Chase Manhattan Bank with more than 200 branches in the U.S. and abroad. Not the least of its holdings are in the drug business. The Rockefellers own the largest drug manufacturing combine in the world and use all of their other interests to bring pressure to increase the sale of drugs. The fact that most of the \*12,000 separate drug items on the market are harmful is of no concern to the Drug Trust. (\* As of 2002, there are more than 200,000).

The trend of using animals on a massive scale in medical research was started in America, by John D. Rockefeller, who had learned from his pappy, a horse-thief, bigamist and travelling salesman of snake-oil as a sure-fire cancer remedy, the limitless gullibility of the general public, and how to exploit it. JDR's evil genius gave him the idea to involve governments in the profits from the sale of lucrative but deadly "miracle" drugs, which had constantly to be replaced by new ones, after the advertised "miracles" had not only failed to materialize but had furthermore opened big scars, mental and physical ones, in the nation's health. Exactly how the Rockefeller principle was organized and sold to all other industrialized countries has been exhaustively described by Morris Bealle in *The Drug Story* (1949) and by Hans Ruesch in *Naked Empress* (1982).

After giving instances of the fabulous profits from the sale of these drugs, Bealle writes: "Is it any wonder that the Rockefellers and their stooges in the Food and Drug Administration, The U.S. Public Health Service, the Federal Trade Commission, the Better Business Bureau, the Army Medical Corps, the Navy Bureau of Medicine, and thousands of health officers all over the country, should combine to put out of business all forms of therapy that discourage the use of drugs.

The last annual report of the Rockefeller Foundation itemizes the gifts it has made to colleges and public agencies in the past 44 years and they total somewhat over half a billion dollars. These colleges, of course, teach their students all the drug lore the Rockefeller pharmaceutical houses want taught. Otherwise there would be no more gifts, just as there are no gifts to any of the 30 odd drugless colleges in the United States.

Harvard, with its aristocratic background and well-publicized medical school, has received \$8,764,433 of this Drug Trust money. Yale got \$7,927,800, John Hopkins \$10,418,531, Stanford \$947,505, Washington University in St. Louis \$2,842,132, New York's Columbia University \$5,424,371, Cornell University \$1,709,072, etc., etc." -from M. Bealle, *The Drug Story*, 1949, pg. 19

The American Medical Association (AMA) has a long history of corruption. Its most infamous leader was Morris Fishbein who reigned from 1924 until 1949. He had failed anatomy in medical school and had never practised medicine a day in his life, but during his years in power he was recognized as the virtual dictator of American medicine. Journalist and scholar Ruth Mulvey Harmer, Ph.D. characterized Fishbein as having the "ruthlessness of a shark" and concluded that he "managed to hold back the twentieth century for 50 years for the benefit of organized medicine". "Miracle" Drugs or Deadly Duds - An editorial in The Economist, London, January 6, 1973, opened thus: "Thalidomide is not the first nor the last drug to have brought heartbreak where it was meant to bring help. There have been quite a number of other tragedies since Thalidomide went wrong 13 years ago. After 'extensive' so-called 'safety-tests ' on animals, of course, when this 'anti-nausea' pill was prescribed for pregnant women, being 'perfectly safe for mother and child", or so the manufacturer promised.

The doctors can't see further than their own noses. They have become convinced by the laboratory-financed medical literature that medicines have turned them into demi-gods, and that attacks on the pharmaceutical industry mean attacks on medicine.

Some 10% (or 400,000) of the nearly 4 million yearly admissions to Canadian hospitals result from the intake of prescribed drugs. But once in hospital people are still not safe from mis-prescribing and adverse reactions to drugs. More than 200,000 serious injuries (including death) result from drug therapy in Canadian hospitals every year. Studies have determined that adverse drug reactions can contribute to 36% of all deaths in hospitals, and 25% of such deaths may be due to directly fatal poisoning. Most adverse effects will double the time of the average stay in hospital. Many years ago, Dr. Walter Modell of Cornell University's Medical College, whom Time magazine had described as "one of America's foremost drug experts", wrote in Clinical Pharmacology and Therapeutics: "When will they realize that there are too many drugs? No fewer than 150,000 preparations are now in use. About 15,000 new mixtures and dosages hit

the market each year, while about 12,000 die off...We simply don't have enough diseases to go around. At the moment the most helpful contribution is the new drug to counteract the untoward effect of other new drugs." (Time, May 26, 1961)

In the German medical journal Muenchener Medizinische Wochenschrift (No. 34, 1969), Dr. W. Chr. Mueller of the 1st University Hospital for Women, Munich, reported after one of the most comprehensive studies in this area of medicine that: "... 61 percent of all deformities in new-born infants and 88 percent of all stillbirths must be attributed to the effects of medicaments."

In Die Weissen Magier (The White Magicians), Bertelsmann Verlag, 1974, Kurt Bluechel gives the following figures for West Germany: "Only 25 years ago, among every 100,000 children born in the Federal Republic there were 3 cases of malformation. Today, 5 children are malformed for only 1,000 births. Within a quarter of a century, therefore, the malformations have increased more than a hundredfold."

And on page 257 Bluechel states: "The average German citizen today consumes about five times as many medicines as in the years immediately preceding the Second World War. Is he also five times healthier? Of course not. On average the West German population is far more frequently ill today than it was in those days..."

Swiss State News on TV on May 30, 1988: "The use of Accutane, a Hoffman-LaRoche product, has caused hundreds of defective births. The packages containing this drug will henceforth have to display the picture of a malformed newborn." ...Not banned, mind you...no criminal prosecution...

### **Practocol causes blindness**

A.D. Dayan, who represented the European Federation of Pharmaceutical Industries at the European Parliament of Strasbourg in 1982 and also works for the Wellcome Research Laboratories, revealed: "Practocol was prescribed over 4 years before doctors realised that it caused corneal damage including blindness - a side effect not predicted by animal experiments." C.T. Dollery in Risk-Benefit Analysis in Drug Research, Ed. J.f. Cavalla, 1981, MTP)

Mr. Dayan overlooked many tens of thousands of other drugs that had all been withdrawn from the market by the health authorities of various nations who had first approved them on the basis of these phony "safety" tests on animals. Those "health authorities" included Mr. Dayan himself!

Dr. med. Karlheinz Blank, West Germany, in Der Tierschutz, Nr. 62, 1985, Journal of the Arbeitsgemeinschaft Deutscher Tierschutz (German Animal-Defense Society): "A drug that is tested on animals will have completely different effects in man. There are uncounted examples that could be cited...But a word to the wise ought to be sufficient...'

A single Amanita Phalloides mushroom can wipe out a whole human family, but is HEALTH-FOOD for the rabbit, one of the favorite laboratory animals...

Prof. Bruno Fedi, M.D., Director of the City Hospital of Terni, Italy, anatomist, pathologist, specialist in urology, gynecology and cancerology: "All our current knowledge of medicine and surgery derives from observations of man following especially the anatomical - clinical method introduced by Virchow: symptoms of the patient while alive and the alternations found in the dead body. These observations have led us to discover the connection between smoking and cancer, between diet and arteriosclerosis, between alcohol and cyrrhosis, and so on. Even the RH factor has not been discovered on the macacus rhesus [monkey]. The observations of Banting and Best on diabetes, attributed to experiments on dogs, were already well known. Every discovery derives from observations on humans, which are subsequently tested in animals, and whenever the findings happen to concur, the discovery is attributed to animal experimentation...Everything we know today in medicine derives from observations made on human beings. The ancient Romans and Greeks gained most of their knowledge from epidemiological studies of people. The same goes for surgery. Surgery can't be learned on animals...Animals are anatomically completely different from man, their reactivity is completely different, their structure and resistance are completely different. In fact, exercises on animals are misleading. The surgeon who works a lot on animals loses the sensibility necessary for operating on humans." Professor J. Clausen of the Institute of Preventive Medicine at the University of Odense stated in March 1973: "Millions of people have been vaccinated with the polio vaccine, which contains the cancer-forming SV-40 virus originally found in monkeys. It is possible that it will take 20 years or still longer before the possible damaging effects of this virus come to light."

How can there be such varying views? Mainly, vaccination programs and antibiotics have deliberately and wrongly been given all the credit for naturally-occurring declines in killer diseases such as smallpox, cholera, typhoid, tuberculosis, dysentery, etc., whereas most or all the credit belongs to better hygiene, sanitation, housing, and greater resistance to disease thanks to improved economic conditions - better nutrition being particularly important in the case of tuberculosis.

London's typhoid epidemics were being halted by changes in the water supply before the "bug" was discovered, let alone a vaccine was developed - according to a 1923 report in the British Medical Journal. But tendentious legends has it that the vaccine saved the lives of thousands of troops in the Boer War and the 1914-1918 war. The documented truth is that typhus hit vaccinated soldiers and citizens with about the same frequency as unvaccinated ones, with the only difference that an unspecified number of vaccinated people developed the well known post- vaccinal effects - immediate insurgence of the disease against which they had been vaccinated, meningitis, and death.

The issue is also confused by health professionals' consistent inability or unwillingness to identify vaccine-related deaths. A University of California study has shown that at least 1,000 deaths a year, described as the mysterious SIDS (Sudden Infant Death Syndrome), are in fact caused by vaccines. "Vaccines are made from: mucus of infected children (whooping cough), excrement from typhoid victims (typhoid), fermented chick embryos, and until recently vaccines for polio were got from the diseased kidneys of monkeys, and cause: leukemia, encephalitis, Multiple Sclerosis - and: "Now I believe the smallpox-vaccine theory is the explanation to the explosion of AIDS". World Health Organization, advisor, Times 11.5.87

Dr. med. Steintl, Berlin, on International Medical Policy "...In order to practice their 'gentle art', the doctors require millions of animals for torture, on whose suffering their 'science' is based. But when it dawned on some people that the system was rotten, and clear-sighted individuals fought against it, the doctors also saw that their livelihood was being threatened. Their medical policy is primarily the line of withholding information. 'The amount of information to be given is determined by us', said Dr. med. Neustedter.

The prerequisite for today's medical policy is naturally the currently predominant system of medicine. The sick are the source of income, therefore it is necessary for sick people to be there, yes, it proves advantageous if one makes the people artificially sick.

Hundreds and thousands of perjuries have been committed via falsified scientific reports. I say this, because I can prove it. By means of these the high standing of the doctors is forced on the public. Damage thus comes about as a result of vaccination, and is constantly proven. But it is portrayed in a very toned down form by official sources. Since 1930 many doctors have declared themselves opposed to vaccination. But the vaccination law continues to prevail. In many German States there is compulsory vaccination, although even the supporters of vaccination were originally against compulsion.

In 1929 it so happened that a father abducted his own child three times so as to save it from the persecution of those who wanted to use force in order to vaccinate the child. After the vaccination, encephalitis (inflammation of the brain) set in, and within eight days the child was dead! ## CIA - AMERICA'S PREMIER INTERNATIONAL TERRORIST ORGANIZATION



### **Operation Mockingbird: CIA Media Manipulation** By Mary Louise

The CIA's secret activities, covert missions, and connections of control are all done under the pretense and protection of national security with no accountability whatsoever, at least in their minds. Considering the public is held accountable for everything we think, say, and do there is something seriously wrong with this picture. The CIA is the President's secret army, who have been and continue to be conveniently above the law with unlimited power and authority, to conduct a reign of terror around the globe.

The "old boy network" of socializing, talking shop, and tapping each other for favors outside the halls of government made it inevitable that the CIA and Corporate America would become allies, thus the systematic infiltration and takeover of the media.

### **American Hoocaust**

Under the guise of 'American' objectives and lack of congressional oversight, the CIA accomplish their exploits by using every trick in the book (and they know quite a few) that they actually teach in the notorious "School of the Americas", nicknamed the "School of Dictators" and "School of Assassins" by critics. The Association for Responsible Dissent estimates that 6 million people had died by 1987 as a result of CIA covert operations, called an "American Holocaust" by former State Department official William Blum. In 1948, the CIA recreated its covert action wing called the Office of Policy Coordination with Wall Street lawyer Frank Wisner as its first director. Another early elitist who served as Director of the CIA from 1953 to 1961 was Allen Dulles, a senior partner at the Wall Street firm of Sullivan and Cromwell, which represented the Rockefeller empire and other trusts, corporations, and cartels.

### **Operation Mockingbord**

Starting in the early days of the Cold War (late 40's), the CIA began a secret project called Operation Mockingbird, with the intent of buying influence behind the scenes at major media outlets and putting reporters on the CIA payroll, which has proven to be a stunning ongoing success. The CIA effort to recruit American news organizations and journalists to become spies and disseminators of propaganda, was headed up by Frank Wisner, Allen Dulles, Richard Helms, and Philip Graham (publisher of The Washington Post). Wisner had taken Graham under his wing to direct the program code-named Operation Mockingbird and both have presumably committed suicide.

Media assets will eventually include ABC, NBC, CBS, Time, Newsweek, Associated Press, United Press International (UPI), Reuters, Hearst Newspapers, Scripps-Howard, Copley News Service, etc. and 400 journalists, who have secretly carried out assignments according to documents on file at CIA headquarters, from intelligence-gathering to serving as go-betweens. The CIA had infiltrated the nation's businesses, media, and universities with tens of thousands of on-call operatives by the 1950's.

**CIA Director Dulles had staffed the CIA almost exclusively with Ivy League graduates, especially from Yale with figures like George Herbert Walker Bush from the "Skull and Crossbones" Society.**

Many Americans still insist or persist in believing that we have a free press, while getting most of their news from state-controlled television, under the misconception that reporters are meant to serve the public. Reporters are paid employees and serve the media owners, who usually cover when challenged by advertisers or major government figures. Robert Parry reported the first breaking stories about Iran-Contra for Associated Press that were largely

ignored by the press and congress, then moving to Newsweek he witnessed a retraction of a true story for political reasons. In 'Fooling America: A Talk by Robert Parry' he said, "The people who succeeded and did well were those who didn't stand up, who didn't write the big stories, who looked the other way when history was happening in front of them, and went along either consciously or just by cowardice with the deception of the American people."

Major networks are primarily controlled by giant corporations that are obligated by law, to put the profits of their investors ahead of all other considerations which are often in conflict with the practice of responsible journalism. There were around 50 corporations a couple of decades ago, which was considered monopolistic by many and yet today, these companies have become larger and fewer in number as the biggest ones absorb their rivals. This concentration of ownership and power reduces the diversity of media voices, as news falls into the hands of large conglomerates with holdings in many industries that interferes in newsgathering, because of conflicts of interest. Mockingbird was an immense financial undertaking with funds flowing from the CIA largely through the Congress for Cultural Freedom (CCF) founded by Tom Braden with Pat Buchanon of CNN's Crossfire.

Media corporations share members of the board of directors with a variety of other large corporations including banks, investment companies, oil companies, health care, pharmaceutical, and technology companies. Until the 1980's, media systems were generally domestically owned, regulated, and national in scope. However, pressure from the IMF, World Bank, and US government to deregulate and privatize, the media, communication, and new technology resulted in a global commercial media system dominated by a small number of super-powerful transnational media corporations (mostly US based), working to advance the cause of global markets and the CIA agenda.

The first tier of the nine giant firms that dominate the world are Time Warner/AOL, Disney/ABC, Bertelsmann, Viacom/CBS, Rupert Murdoch's News Corporation/Fox, General Electric/NBC, Sony, Universal/Seagram, Tele-Communications, Inc. or TCI and AT&T. This is just the head of the octopus which has its second and third tier tentacles working together in unison or feigned division. This would include The Washington Post/Newsweek, The New York Times/Weekly Standard, Tribune Co., US News, Gannett/USA Today, Dow Jones/Wall Street Journal, Washington Times, Knight-Ridder, etcetera.

Journalists Carl Bernstein and Bob Woodward broke the stories on Watergate (late 70's) in the Washington Post, having gained access to what the CIA was trying to keep from congress about its program of using journalists at home and abroad, in deliberate propaganda campaigns. It was later revealed that Woodward was a Naval intelligence briefer to the White

House and knew many insiders including General Alexander Haig. A high-level source told Bernstein, "One journalist is worth twenty agents." CFR/Trilateralist Katharine Graham, in a 1988 speech given to senior CIA employees at Agency headquarters said, "We live in a dirty and dangerous world. There are some things the general public does not need to know and shouldn't. I believe democracy flourishes when the government can take legitimate steps to keep its secrets and when the press can decide whether to print what it knows." Maybe that's another reason why folks get the impression that a suspicious agenda lurks behind the headlines. #### **Corporate Ownership**

Almost all media that reach a large audience in the United States are owned by for-profit corporations--institutions that *by law* are obligated to put the profits of their investors ahead of all other considerations. The goal of maximizing profits is often in conflict with the practice of responsible journalism.

Not only are most major media owned by corporations, these companies are becoming larger and fewer in number as the biggest ones absorb their rivals. This concentration of ownership tends to reduce the diversity of media voices and puts great power in the hands of a few companies. As news outlets fall into the hands of large conglomerates with holdings in many industries, conflicts of interest inevitably interfere with newsgathering.

FAIR believes that independent media are essential to a democratic society, and that aggressive antitrust action must be taken to break up monopolistic media conglomerates. At the same time, non-corporate, alternative media outlets need to be promoted by both the government and the non-profit sector.
